Client Information

For your pet's protection, all vaccines must be current. Bordetella, a specific kennel cough vaccine, is required every 6 months. A fecal exam will be run on your pet every 6 months or every month depending upon the heartworm prevention he or she is taking. Your pet must be free of internal and external parasites. If not, treatment will be done at your expense. The kennel is not responsible for any personal belongings left with your pet.

Each Pet will be charged a \$5.00 "Pet Warranty" fee per Boarding Visit (not per day) which will cover any medical problems that occur during or within 48 hours of that boarding stay. Any problems that exist before the boarding stay will not qualify, and will be documented at check-in.

Deluxe Accommodations

Deluxe accommodations include lodging in our specially designed Suites, Runs, or Cat Condominiums; Room service is provided twice a day with Purina EN or Science Diets (or, if you prefer, owner-provided food). Fresh water is available at all times with automatic water dispensers. Your pet's quarters are cleaned and sanitized at least once a day. Exercise will be provided five times a day in our play yards. We are happy to administer any medications or vitamins brought from home for an additional fee. Please let us know if you wish your pet to be freshly bathed prior to discharge (additional charge applies).

Financial Policy:

We will gladly prepare a written estimate if you desire. All fees are due at the time of check-out, unless required to be pre-paid. Please circle your method of payment: CASH CHECK MASTERCARD VISA
A returned check fee of \$30 will be charged to any account whose check is returned by the bank for insufficient funds or account closed. Any outstanding balances aged over 45 days will be subject to a \$6 billing fee plus 1.5% interest each month until paid in full.
